# RECENTLY FINALIZED PROJECTS



**BESCO E&C** has accomplished an extraordinary milestone by successfully completing the full civil and mechanical scope for SWCC's largest desalination intake and intermediate plant in the Jubail Region. This state-of-the-art facility is set to produce an impressive 1 million cubic meters of water daily, earning its recognition in the prestigious Guinness World Records.

## Here are some of the key highlights of the projects

- ❖ The **Intake station**, being primary structure, was successfully completed within six months, ahead of the anticipated timeline provided by SWCC.
- ❖ The **Intake pump station** consisted of four drum screens and six vertical pumps, each reaching a height of 11 meters and boasting an individual capacity of 1250 hp.
- ❖ The primary structure houses an encapsulated electrical transformer with a generation capacity of 200 megawatts.
- ❖ The **Intermediate pump station** features four vertical pumps, each standing 11 meters tall and delivering an impressive capacity of 1,150 hp.
- ❖ Heavy design structure .
- ❖ A specialized cathodic protection design has been implemented to prevent decay and oxidation effectively.
- ❖ Seamless coordination between the CWG and EWG has been established for the testing and handover phases of the project.

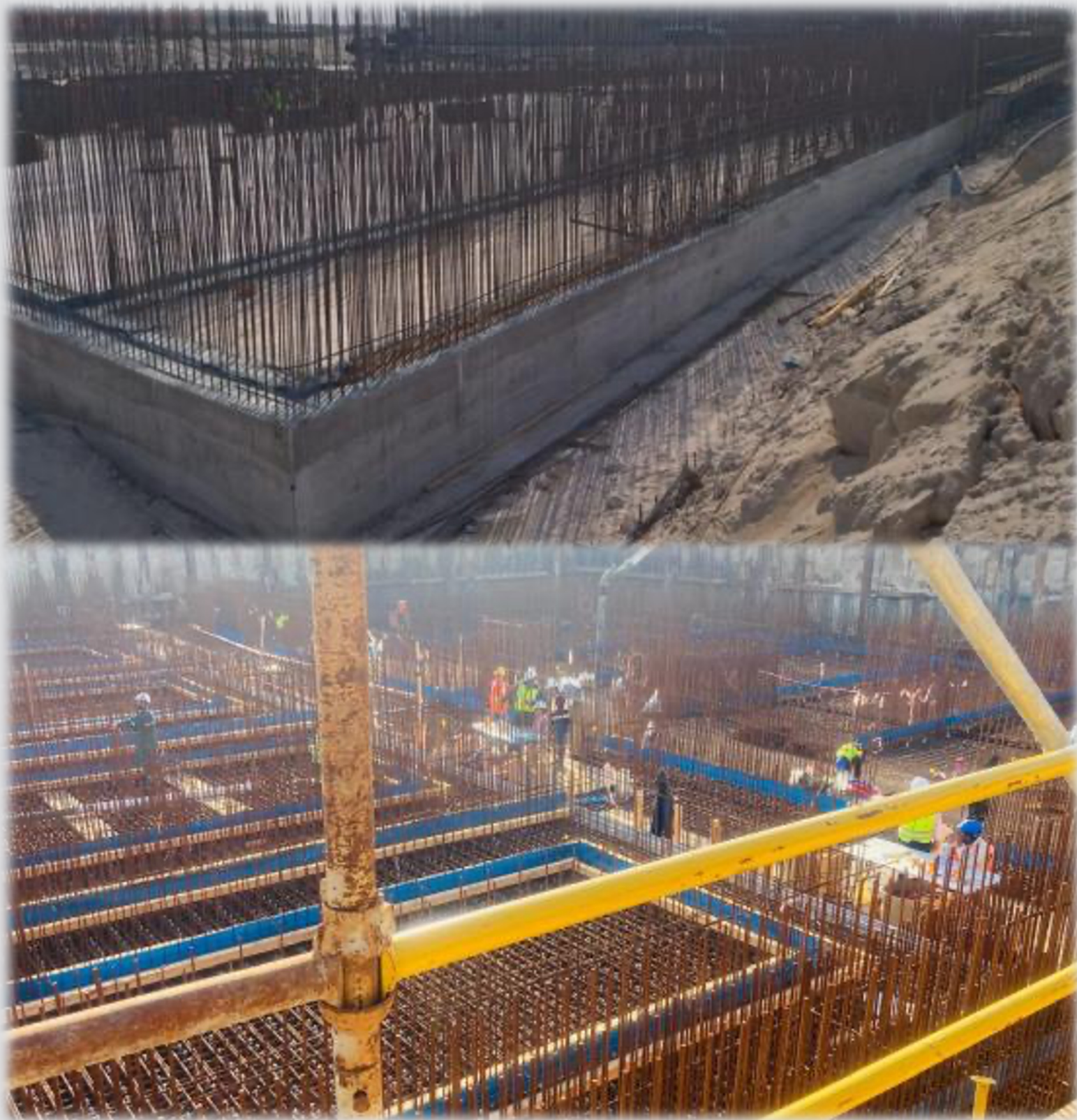
